Veterans Day is more than just a day off; it's a time to show gratitude. Whether through attending local parades, volunteering at a Veterans'





WATCH OUT FOR BROWN FRIDAY, SCHEDULE A PLUMBING CHECKUP

Now is an ideal time to call a plumber to clear your pipes before Thanksgiving, when guests might unknowingly send turkey and stuffing scraps down the garbage disposal. This is part of the reason why plumbers refer to the day after Thanksgiving as "Brown Friday."

When you're busy cooking and cleaning, it's easy to overlook what's going down the drain, and that's when things can go wrong. Well-intentioned family members who help with the dishes may end up clogging the drain with Thanksgiving leftovers.

To prevent clogs, throw kitchen scraps, especially starchy foods that expand, into the trash and only use the disposal for small crumbs. Also, grease should never be poured down the sink, as it coats pipes and creates sludge.

INGREDIENTS

- G 3 cups mashed sweet potatoes
- □ 1 cup sugar
- □ 3 large eggs
- □ 1/2 cup 2% milk
- □ 1/4 cup butter, softened
- □ 1 teaspoon salt
- □ 1 teaspoon vanilla extract

TOPPING

- □ 1/2 cup packed brown sugar
- □ 1/2 cup chopped pecans
- □ 1/4 cup all-purpose flour
- □ 2 tablespoons cold butter

INSTRUCTIONS

01: Preheat oven to 325°. In a large bowl, beat the sweet potatoes, sugar, eggs, milk, butter, salt and vanilla until smooth. Transfer to a greased 2-qt. baking dish.

02: In a small bowl, combine the brown sugar, pecans and flour; cut in butter until crumbly. Sprinkle over sweet potato mixture. Bake, uncovered, until a thermometer reads 160°, 45-50 minutes.
